2021 Board of Directors Nomination Form

The California Stormwater Quality Association (CASQA) is holding its annual Board of Directors election in September – November 2020. The new Board will be seated in January. Members are encouraged to nominate candidates for the Board of Directors. In accordance with the CASQA Bylaws, the CASQA Board of Directors is composed of 11 members. Directors are elected to two-year terms and approximately one-half of the positions are up for election every year. For the 2021 - 2022 two-year term, five Director Positions are up for election. Two of these Directors must represent permitted stormwater MS4s and three of these Directors may represent any Non-MS4 category of membership. In the event there are insufficient nominees in the MS4 category to fill the Director positions, those positions become at-Large and may be filled by duly authorized or elected representatives of any membership category.

The Board of Director Positions up for re-election for 2021 are currently held by: Delyn Ellison-Lloyd, Municipal Consulting Group (Non-MS4); Cathleen Gamand, County of Santa Barbara (MS4); and Dave Tamayo, County of Sacramento (MS4). Additionally, the Director positions currently held by Daniel Apt, Olaunu, LLC (Non-MS4) and Brian Currier, CSUS-Office of Water Programs, (Non-MS4) are being vacated for 2021 because of term limits.

Remaining on the Board for 2021 are: Richard Boon, Riverside County Flood Control & Water Conservation District (MS4); Amanda Carr, County of Orange (MS4); Jamison Crosby, Napa County Flood Control & Water Conservation District (MS4); Dalia Fadl, City of Rancho Cordova; Mark Lombos, Los Angeles County (MS4); and Kirsten Struve, Santa Clara Valley Water District (MS4).

Nominees and persons nominating must be members of CASQA. Self-nominations will be accepted. **Nominations will be accepted until 5 pm PDT on Friday, October 9, 2020.** Nominees must be willing and able to participate in Board of Directors meetings and carry out the business of the Board. For more information on the role of Directors, ask for the *CASQA Director's Guide*. Nominees that meet the qualifications and accept their nomination will be placed on the ballot for the election.
